### TERMS & CONDITIONS

- 1) 3 Gate Passes (wristbands) per site. Please always wear your wristband.  
Additional Staff Wristbands Half Price At Application.  
**No Wristband = No Entry.** Anyone without a wristband will be escorted from the Showground.
- 2) Power available to Sites as an optional extra, cost \$25 per day.
- 3) Stall Holders are **NOT** permitted to conduct raffles at the Kempsey Show.
- 4) Stalls **MUST** be Operated from 8am to 8pm both show days
- 5) Campsite **NOT** included in Trade Site Fees, extra costs payable.
  - a. **Camping Fees:** \$30 per night (2 people per site) – Additional people \$15 each per night
  - b. Stall Holders **MUST** camp in the camping sites provided at the Showground.
  - c. Vehicles to be parked at Camp Site, **NOT** at Trade Site
- 6) CLEANING BOND for all Food Sites: \$100.00. Refundable after inspection by Operator and Show Society Committee Member.
- 7) All Site Holders must operate & display their goods within the confines of the area for which they pay & have been allocated space. Any contravention of this regulation will result in the automatic cancellation of that space holders right to occupy space for the immediate cessation of his/her trading operations at the Show, with no refund of any fees paid.
- 8) No Site holder shall obstruct the use of any firefighting equipment or electrical switchboards & must always maintain free access to such equipment.
- 9) The Kempsey Show Society accepts no liability for damages to exhibits by loss, damage, theft, fire, water, storms, strikes, riots, or any other cause whatsoever.
- 10) All Site holders are responsible for the removal of rubbish from their sites or forfeit their Cleaning deposit.
- 11) All Site holders intending to bring electrical equipment to the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers & that all electrical leads, tools & appliances have been inspected & tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow site holders, & the public, & is a requirement of the Work Health & Safety Act of 2011.
- 12) Damage caused to the Showground buildings, fittings i.e. electrical / waterlines must be repaired by the Site Holder. If the Site Holder does not comply with this regulation, it the Committee's Right to refuse participation as an exhibitor in future Kempsey Shows.
